#### Announcement on resuming Collective Worship

Cardinal Vincent welcomed the Prime Minister's announcement on 23rd June that collective acts of worship can resume, saying: 'I welcome the statement by the Prime Minister earlier today, that places of worship are now able to resume collective acts of worship from 4th July. This is welcome news for members of all religions in England. I thank all who have worked hard to bring this about, not least my fellow religious leaders.

'As Catholics we now look forward to being able to celebrate Mass together again from 4th July. We have waited with patience and longing for this moment, understanding the importance of protecting the health of people in our society. Now we are full of anticipation that we will be able again to take part together in the Eucharist, which lies at the centre of our faith.

'It is important that we continue to abide by the guidance, given by the Government, on appropriate social distancing and the other measures to avoid all unnecessary risk. Our own detailed guidance will be distributed around dioceses and parishes so everyone can be confident that they may come to Mass securely and understand the part they are to play in protecting each other from any remaining risk of infection.

'The past few months have been a time of fashioning new patterns of prayer, new ways of exploring and enriching our faith and vigorous ways of reaching out to those in need. We can build on these, forgetting nothing of the graces we have been given. Yet now, with the experience of opening our churches for individual prayer already gained, this return to the more normal patterns of worship will be of great importance to all Catholics.

'This time of our "Eucharistic fast" has made our hearts grow in longing for that moment when we can come together and receive again the Body and Blood of Christ in the Eucharist. That moment is now very near and for that we thank God.'

## Pope's prayer intention for July: For families

As we passed the year's longest day last month, many families felt that this was the longest year ever as so many suffered at various levels from the effects of the pandemic. Families grieved the loss of beloved elders and loved ones while enduring job losses and economic uncertainty. At the invitation of the Pope, in June we contemplated the wounded side of the Saviour and took solace and strength from the blood and water that flowed from his Sacred Heart. We prayed with Pope Francis that many hearts would be touched by that Heart. Now, in July, the Pope invites us to pray with him for families: 'that today's families may be accompanied with love, respect and guidance'.

When Pope Francis decided, in consultation with the leaders of his worldwide prayer group, on the intentions that would be presented to us each month this year, none of us had heard of COVID. Now, halfway through the calendar year, it is the backdrop to everything we pray, say and do. There are signs of hope in some places that it might be ending and signs of magnificent great love in the efforts of healthcare professionals in particular and essential workers everywhere. At every time of prayer in these days, we must pray for them and in thanks for their magnificent service of others.

As we pray with the Pope this month, we might note that we are not only praying for families, although goodness knows we would want to, for our own families, for those who have no family, for shattered refugee families and, at this time, for families devastated by the effects of the contagion. We make that prayer but recognise that the Holy Father invites to a specific intention, that families may be accompanied. Who is to accompany them?

#### Who is responsible?

The answer must surely include a recognition that the human family and each individual family is under threat and therefore that those who have power must act in response. They must be urged to act. 'Love, respect and guidance' should be at the heart of how society accompanies families. It is for good people with the common good at heart to act, to put

pressure on those who have power and those with a vested interest in keeping people poor and fragmenting families. The oldest generation are fully part of our family and society life, or should be.

#### Pope Francis has said that:

'The COVID-19 pandemic has shown that our societies are not organised well enough to make room for the elderly, with proper respect for their dignity and frailty. When the elderly are not cared for, there is no future for the young.'

Praying with the Pope each month for the challenges that face human society must of necessity involve a willingness to act, to mobilise ourselves according to whatever abilities and talents we've been given. These acts can be sacramental embodiments of our faith-filled prayer. The New Testament reminds us that, 'faith without works is dead' (James 2:14-26).

Speaking at a General Audience on 17th June 2020, Pope Francis taught that, 'to pray means to intercede for the world, to remember that despite all its frailties, it always belongs to God'. This is the opposite of the temptation, that comes from the Bad Spirit, to shun the world and to keep your faith private, whatever that might mean. The pandemic presents many possibilities for action, especially this month for families. Let us not forget the very young, especially those whose schooling is interrupted by the pandemic, but also the elderly, who have made us who we are and have sacrificed a great deal for us.

#### **Prayer moment**

Let the Spirit of God lead you to a place of interior stillness and then allow yourself to become aware of God's gaze on you, full of love and hope for you and for all of creation. That gaze is sustaining and life-giving. Ask, in your heart, for a deepening, interior awareness of that divine presence and compassion. Ask for the grace of knowing how the Trinity is shared love and of how the human family reflects that love, making it present in each family member and in the world. Hold before the Lord in prayer families and particularly people who have been deprived of family life, who are not accompanied with love, respect and guidance. Conclude with an intimate conversation with the Lord about his own family life, as one of the Holy Family of Nazareth, as one of the Blessed Trinity. Speak to him about whatever presents itself to your mind and heart at this moment.

# The Pope's Prayer Intention for the month of July: A Prayer for Families

Let us pray that today's families may be accompanied with love, respect and guidance, and especially, that they may be protected by the State.

The family ought to be protected. It faces many dangers: the fast pace of life, stress... Sometimes, parents forget to play with their children. The Church needs to encourage families and stay at their side, helping them to discover ways that allow them to overcome all of these difficulties. Let us pray that today's families may be accompanied with love, respect and guidance, and especially, that they may be protected by the State.

#### Proposals for prayer and action this month

Last month a young, unassuming footballer grabbed the headlines from the politicians by writing a cogent, urgent letter about a government policy that threatened to damage family life and poor children in Britain. Marcus Rashford refused to make any political capital out of his campaign for justice, thanking the government for its embarrassing change of policy when others might have gloated. It was the poor families that were his only concern, and he used his talent and his prominence to advocate for them. He showed how it can be done, with graciousness, but determination. Consider ways in which you might be able to act similarly; alone, in your family, or in your parish or worshipping community.

As you pray the Daily Prayer Pathway, consisting of the Morning Offering, the Midday Moment and the Evening Prayer of Daily Awareness (Examen), ask for the grace to be humbler and more ready to listen to others before judging them. Ponder, gently, any temptation to treat others as less worthy if they do not appear to contribute so much materially or financially. Ask that your heart may be opened to any healing that is needed.

Discuss, as far as is possible while our movements are still restricted, in your own friendship circles or your parish, where there might be possibilities in your own neighbourhood of supporting and accompanying families with 'love, respect and guidance'. Remember the Pope's words: 'To the pandemic of the virus we want to respond with the universality of prayer, of compassion, of tenderness'. Resolve to act!

# **Personnel Updates**

#### APPOINTMENTS: SENIOR LEADERSHIP, CHAPLAIN, & RELIGIOUS EDUCATION RESPONSIBILITY

There have been one or two cases recently where schools have failed to inform us, in reasonable time, of the impending appointment of a Senior Leader, Chaplain or RE post holder. This is contrary to the requirements of the Bishop of England & Wales:

Interview procedures approved by Governing Bodies for teacher recruitment must be open to scrutiny. They must be clear, objective and transparent.

The Diocesan Bishop is entitled to be represented at all proceedings relating to the appointment of senior leaders and teachers of religious education.

Governing Bodies must facilitate the attendance of the Diocesan Director (or his or her nominee), either by affording them advisory rights or otherwise. These may be in relation to all appointments at the school or, more usually, to the appointment of the senior posts to which the requirement to be a practising Catholic are applied.

# **Pupil Placement Planning**

#### 1<sup>st</sup> Planner – Demographic Survey

The Pilot Project is making good progress through Phase 2. 1<sup>st</sup> Planner is engaging with Local Stakeholders in order to refine their data. The Phase 2 report will be presented to the Oversight Committee upon completion. Part of the preparation for stakeholder engagement included the preparation of an introductory video. Fr. Academy Trusts seeking to undertake work on any asset owned by or otherwise controlled by the Trustees of the Diocese of Westminster are required to secure permission to undertake the planned work, prior to the engagement of Contractors. The Capital Strategy Committee has received some proposals for consideration at their meeting on Thursday 9<sup>th</sup> July 2020.

# Statlog

The introduction of Statlog within the Diocese is progressing well.

Schools and Academies are engaging with the software and the main Diocesan Buildings Consultants have received initial training to support this process.

Schools and Academies that fully engage with the Statutory Compliance and Site Survey (Asset management) modules will be permitted to commission Minor Capital Works without the oversight of external consultants. Minor Works are usually those funded from Local Funding i.e. DFC, Governors Voluntary Funds or the School's revenue budget. School Business Managers and other School Leaders will be trained to use Statlog in order to safeguard themselves, their schools and the Diocesan Trustees.

Major Works will also be processed using Statlog. The prioritisation of work for funding in 2021 and beyond will be managed within Statlog. The Diocese will use the Survey Data within Statlog to identify and rank urgent work. VA Schools will not have access to VASCA until they fully engage with Statlog.

## **Priority School Building Programme**

Project managers continue to monitor the progress of schools in this scheme. Some contractors can make headway whilst ensuring social distancing.

#### VASCA 2020/21

34 Projects are now live on Statlog. School Leaders and Governors from those schools, with the support of their Building Consultants, are fully engaged in the process of scoping and procuring the essential work approved by the Education Commission.

What parents and carers need to know about early years providers, schools and colleges during the coronavirus (COVID-19) outbreak – Updated 2 July and 30 June

(Added guidance for parents and carers about early years providers, schools and colleges in the autumn term, content on summer provision, school uniform and a package of support worth £1billion to support pupils to catch up; updated content on school meals and the Covid Summer Food Fund.)

Actions for early years and childcare providers during the coronavirus (COVID-19) outbreak – Updated 2 July (Updated to set out a change to the protective measures in early years settings that will be effective from 20 July, removing the requirement to keep children in small consistent groups within settings (sections 2.1 and 3.3). Added new content on risk assessment (3.1), supporting staff with increased risk factors (3.2) and system of controls (3.3). Updated content on attendance at settings for those shielding, with changes to the advice effective from 1 August, and removal of content on vulnerable children since settings are open for all children (section 4). Updated content on wraparound care (5.3). Updated Early Years Foundation Stage reforms (7.6) and Reception Baseline Assessment (7.7).)

#### Awarding qualifications in summer 2020 – Updated 2 July

(Summer 2020 grades for GCSE, AS and A level, Extended Project Qualification and Advanced Extension Award in maths: Guidance for teachers, students, parents and carers document updated to reflect autumn 2020 consultation decision outcomes and 2021 exam series consultation proposals.)

Providing free school meals during the coronavirus (COVID-19) outbreak – Updated 30 June (Updated application form and guidance on the temporary extension of free school meals eligibility to NRPF groups. This is to reflect the change in annual household income threshold to £16,190 after tax.)

#### Summer holiday arrangements

The Secretary of State for Education has confirmed that schools are not being asked schools to open over the summer holidays, and there is no expectation that schools should open for vulnerable children and children of critical workers over this period. Teachers, support staff and school leaders deserve a break, to recharge and rest. However, we are aware that some school leaders may be considering using their catch-up premium to provide summer school activities for their pupils. Where this is the case, you have the flexibility, discretion and autonomy to decide how you want to do this. To support schools in planning how to use the catch-up premium, the Education Endowment Foundation (EEF) has produced a guide, which includes advice on summer schools and a link to the Teach First toolkit specifically focuses on summer schools, for schools that choose to do this.
