FREE CES online training course

The Catholic Education Service, in partnership with Ten:Ten Resources, is providing training for teachers in Catholic Primary and Secondary Schools on the new statutory RSHE (Relationship, Sex and Health Education) curriculum. The training is FREE and has been funded by the Department of Education. There is no limit to the number of the people that can complete this training. This can be completed by any staff e.g. teachers, support staff, governors.

- The training is for all schools not just those who are choosing to follow the Ten: Ten life to the full programme.
- The training is about RSE in a Catholic school NOT about the Ten:Ten programme. There is a brief mention of the programme (among other resources) in unit 6.
- Those who complete all 6 units of the training will gain an accreditation from the CES but you can complete only some of the units if you choose

- 5. Breaking down the CES Model Curriculum

Prayer with the Church's liturgy

On consecutive days during September, the calendar of our Church presents feast days of the Exaltation of the Holy Cross followed by Our Lady of Sorrows. Coming at the mid-point of the month, these two holy days could enlighten our prayer. Mary stood mournfully by her Son's Cross; she still does. What is that cross today? We are called, not to regret the cross or shy away from it, but to exalt it, hold it high in the world. God's creation, God's free gift is being crucified by us in our freedom.

It is difficult, after many months of lockdown and a great deal of personal tragedy and suffering, to keep in mind that there are other huge concerns that face humanity. It is also difficult, at times, to remember that a great deal of good is being done by many people. As St Ignatius knew, the Bad Spirit is very likely to nudge us towards the negative, undermining our Christian hope and leading us to think that we can't do anything about our situation. The Good Spirit, that comes from God, reminds us of the opposite, the truth that sets us free. Ponder, in your quiet time this month, the good that is happening; those many acts of kindness as the pandemic has deepened, the scientists working tirelessly towards vaccines, the selflessness of so many healthcare professionals, the researchers and writers bringing to our attention the real concerns about our environmental dangers. If we feel weak and defenceless in the face of so much danger, pray to become more aware of our deep human interconnectedness, which is where true hope is to be found; the hope that impels us, with Mary, to hold high the Cross for all of humanity to see.

Three proposals for the month

- 1. Read the <u>report</u>, on the British Jesuit website, from Jesuit writer Jacques St Laurent SJ about Earth Overshoot Day, particularly his suggestions about how to bring about change.
- 2. Look for one extra thing you could do to reduce consumption in your life or your family's lives. It might be something apparently quite tiny.
- **3.** A local intention: is there a version of this month's intention that you could pray in your parish or worshipping community? Speak to your friends and your parish leaders about this.

A morning offering prayer

This prayer, perhaps adapted to your own or your community's situation, could begin each new day, offering the day ahead for God's greater glory and the common good:

Merciful Father, I pause for a few moments, at the beginning of this day, to be in your abiding presence. May your Spirit guide me today and lead me in all that is true, good and beautiful. Grant me the grace to live the gospel and infuse in me a love for all people and for the whole of creation, your free gift to us all. I offer you my heart this day, united to the intention of Pope Francis for this month. Our Father ...

Catholic Schools feeding the hungry during Covid-19 pandemic

The coronavirus pandemic has pushed many families from a difficult financial situation into an impossible one. Since lockdown began in March, Caritas Westminster has been supporting schools across the Diocese of Westminster as they have rallied to ensure families do not go hungry.

<u>A recent study by Child Poverty Action Group and the Church of England</u> found that 80 percent of low-income families have seen a 'significant deterioration' in their living standards. The same survey found that nearly nine in ten families faced additional costs as a result of coronavirus, and were spending substantially more on food, electricity, and other essentials.

While many schools were already aware of families who were struggling financially, lockdown both highlighted and exacerbated the problem. The Government's Free School Meals voucher scheme faced delays, and schools saw a rising desperation amongst families who had relied on Free School Meals to ensure their children had enough to eat. In response, many schools began buying their own vouchers or setting up emergency food relief schemes.

Danny Coyle, Headteacher of Newman Catholic College in West London, explained that when lockdown started, the school's initial focus was on ensuring students could continue learning from home. However, it wasn't long before the focus moved to ensuring pupils had enough to eat. The school worked with local volunteers who used the school kitchen

to cook emergency meals. Soon, the volunteers were delivering up to 200 meals a day, with funding and support from Caritas Westminster and the Cardinal's Appeal.

Another school in West London set up a weekly food parcel scheme, made up entirely of donations from families at the school. Several parents came forward asking to receive parcels, but others who were in need did not feel comfortable asking for help. The Headteacher made sure these families did not miss out, delivering food parcels to their doorsteps herself.

Some schools are running foodbanks on their premises for the wider local community. David O'Farrell, Headteacher at St Bernadette's school, Harrow, started a foodbank at the school 5 years ago, but since the pandemic he has seen a big increase in the number of people using it. St Elizabeth's school in East London has also opened its own foodbank to meet local need. Tracy Jennings, Deputy Head, told us that schools are perfect locations for foodbanks as they often know who is in need and are well placed to support their communities.

Schools exist to educate children. However, all the schools that Caritas Westminster has been working with felt passionately that it was also their job as Catholic schools to serve their communities. One headteacher said it was important that the Catholic school she leads showed its children a real example of 'the Church's social teaching in action'.

As children return to school, many parents will be relieved to see their children receiving free hot meals again. However, this will not be the case for families with No Recourse to Public Funds (NRPF). During the pandemic the Government extended Free School Meals vouchers to families whose immigration status means they are not entitled to essential welfare support, but this provision is ending as term starts. Schools told Caritas Westminster that these families are often the most in need, but they go under the radar unless they disclose their immigration status. Caritas Westminster has joined with 60 other organisations in writing to the Education Secretary to call for Free School Meals to be permanently extended to families with NRPF.

Caritas Westminster will continue to support the vital work of Catholic schools and parishes across the diocese as they respond to the ongoing effects of the pandemic. So far, 119 parishes and schools have benefitted from the Caritas Emergency Food Voucher Scheme, with over 40 schools participating in the scheme over the summer holidays. This work has been funded by the Albert Gubay Foundation and the St John Southworth Fund.

Did you know?

CCRS at the Education Service has been completely transformed over the last three years. New tutors have been employed who are knowledgable, engaging and helpful. Participants can now choose to do a presentation or an essay for their assessments and in the final professional modules participates reflect on what

they have learnt and consider practical ways it could benefit their own school's RE and Catholic Life. CCRS at the Education Service has also been effectively transferred online to Zoom and this means participants do not need to leave school early or travel to a hub school.

The Wellbeing for Education Return programme is a joint initiative from the Department for Education, Department of Health and Social Care, Health Education England, NHS England and Public Health England. The programme supports staff working in schools and colleges to respond to the additional pressures some young people may be feeling as a direct result of the Covid-19 pandemic, as well as to any emotional response they or their teachers may be experiencing. Health and Safety Executive spot-checks

The <u>Health and Safety Executive</u> (HSE) has confirmed that it will be carrying out spot-checks in schools as they return to full capacity. Spot checks will take the form of an initial phone call to review the measures taken for reopening, to minimise spread of the virus causing COVID-19. Calls made to schools will evaluate knowledge of <u>DfE Guidance for full opening - School</u> (England) and the control measures required under health and safety legislation.

School duty holders need to be briefed about the HSE spot checks and know about a school's risk assessment and have it to hand if they receive a call from the HSE. Where the initial call raises concerns about a school's approach, it will be referred for a further intervention which may include a visit to the school.

The phone call can last approximately 15 minutes and potential questions which may be asked are as follows:

- Are you currently open?
- How many staff are in?
- Would you say that you are good / average or poor in controlling the risks?
- Have you read and understood Government documents?
- What would you do if:
 - A parent advises they have testing positive
 - A child has tested positive
 - o A member of staff has tested positive
- Do you have a RA in play for COVID?
- Who was involved in putting the risk assessment together?
- Where the TU involved? Which ones?
- How confident are you that staff can keep their recommended 2m social distance?
- Can you list changes that you have made in school to allow the 2m distancing to take place?
- Cleaning what are you doing?
- Do you have areas that are 'high touch points' and what is happening to those areas?
- Do all children have access to sinks?
- Is there hand-sanitiser (at least 70% alcohol) freely available around school?
- What DFE/PH documents have you read/referred to support your RA?

Please do note that these questions have been advised to us by school colleagues who have had a call from HSE, other questions may also be asked during the call.

Please:

- Make sure you reflect current guidance,
- Keep your Risk Assessments under constant review, and up to date,
- And equally as important as 1 and 2, make sure you are doing what your risk assessment says if you do not follow your own control measures, the HSE are not going to like it.

Schools should have now received this initial order; if you have not, please call the Test and Trace helpdesk at 119.

The fastest way to get a test result is to go to a testing site (Best of luck!). Individuals will need a pre-booked appointment or they will not be given a test. People can also order home test kits to be sent directly to them. To book an appointment or order a home kit, please visit:

These routes remain the primary channels for any individuals displaying coronavirus symptoms to get a test.

Making an order for additional coronavirus tests

Schools and FE providers should order additional test kits if they have run out or are running out of test kits.

The portal will open for schools to apply for more test kits on the **16 September 2020**, via this link: https://request-testing.test-for-coronavirus.service.gov.uk.

Kits will be supplied in boxes of 10. The number of boxes available to each school or FE provider will be proportionate to your size.

You will be able to make a new order for coronavirus test kits 21 days after you receive a delivery confirmation email telling you that your kits have been sent.

Schools and FE providers will need a Unique Organisation Number (UON) to place orders for test kits. You will receive your UON by email to this email address on or before 16 September 2020. After this date, please call the Test and Trace helpdesk on 119 if you have not received your UON.

Join the Department of Health and Social Care (DHSC) webinar for schools and FE providers

The DHSC are hosting a series of webinars to support schools in understanding how to use the test kits which are being sent to education settings. During these webinars, participants will be given guidance on who should receive these kits, what they will look like and how they should be used. There will also be an opportunity to ask questions.

It is strongly advised for each school to sign up to one of the webinars. The content is being updated after each webinar to capture questions and feedback from the previous webinars.
