### **Religious Education, Collective Worship and the Celebration of Mass in schools COVID-19 – CES Guidance**

During this academic year, with all of its additional complexity, it is important that Catholic school leaders ensure that any modification of timetables to accommodate 'catch-up' curricula are not made at the expense of Religious Education. As the core of the core curriculum, Religious Education must continue to be given full parity with other core curriculum subjects and the requirement remains that it must constitute at least 10% of the taught curriculum from Early Years to the end of year 11, and 5% of the taught curriculum in sixth form.

It should also be clear that in such trying times finding ways to unite our school communities in prayer is more important than ever. School leaders should ensure that daily prayer and liturgy remain at the heart of the Catholic schools so that children and young people, as well as staff, can be consoled by the sure knowledge of the presence of God with them. Of course, all gatherings for shared prayer and the celebration of the Liturgy should observe social distancing, ensure that the integrity of 'bubbles' is preserved and conform to the school's risk assessment for the full return of pupils to school. Such risk assessments must also conform to whatever regulations apply in dioceses and local authorities, as summarised below.

Whilst all legal restrictions on the public celebration of religious services were lifted in July, collective acts of worship, for example the celebration of Mass, must comply with the Government's public health and social distancing guidance. The Catholic Bishops' Conference of England and Wales (CBCEW) has published guidance for the celebration of Mass and the Government has published advice on the safe use of places of worship. If, however, the celebration of Mass takes place in school, the guidance for class or year group bubbles should be followed along with the guidance below for the celebrant. In any event "If a Catholic parish school or its grounds is to be used for Mass, a separate risk assessment has to be done, the appropriate school authority (Governing Body or Trust) has to give its permission, and both the parish and school

insurers should be informed before the event takes place.” (CBCEW *Guidance for the Celebration of Mass 3 August 2020 Revision 10*)

In addition, any separate liturgical and/or health and safety guidance from individual dioceses should also be followed. Similarly, if the school is situated in an area that is experiencing a local COVID-19 outbreak and where local restrictions have been imposed different guidance will apply. As you will be aware, the wearing of face coverings is a matter for individual schools except in areas of national intervention. Nationwide, while the government is not recommending face coverings are necessary, schools will have the discretion to require face coverings in communal areas if they believe that is right in their particular circumstances. In addition, the government has advised additional measures are taken in areas of national intervention as listed on <https://www.gov.uk/> The government’s guidance states that in those areas face masks should be worn by adults and pupils in secondary schools when moving around the school, such as in corridors and communal areas where social distancing is difficult to maintain.

All guidance remains under review and may be updated in line with the changing situation.

This **online children's mental health training** course developed from our work in schools, enhances professionals' understanding of children's mental health and introduces approaches that foster positive wellbeing in schools and communities. There are versions for teachers, student teachers and youth workers.

## Health and Safety Executive spot-checks

The [Health and Safety Executive](#) (HSE) has confirmed that it will be carrying out spot-checks in schools as they return to full capacity. Spot checks will take the form of an initial phone call to review the measures taken for reopening, to minimise spread of the virus causing COVID-19. Calls made to schools will evaluate knowledge of [DfE Guidance for full opening - School](#) (England) and the control measures required under health and safety legislation.

School duty holders need to be briefed about the HSE spot checks and know about a school's risk assessment and have it to hand if they receive a call from the HSE. Where the initial call raises concerns about a school's approach, it will be referred for a further intervention which may include a visit to the school.

The phone call can last approximately 15 minutes and potential questions which may be asked are as follows:

- Are you currently open?
- How many staff are in?
- Would you say that you are good / average or poor in controlling the risks?
- Have you read and understood Government documents?
- What would you do if:
  - A parent advises they have testing positive
  - A child has tested positive
  - A member of staff has tested positive
- Do you have a RA in play for COVID?
- Who was involved in putting the risk assessment together?
- Where the TU involved? Which ones?
- How confident are you that staff can keep their recommended 2m social distance?
- Can you list changes that you have made in school to allow the 2m distancing to take place?
- Cleaning - what are you doing?
- Do you have areas that are 'high touch points' and what is happening to those areas?
- Do all children have access to sinks?
- Is there hand-sanitiser (at least 70% alcohol) freely available around school?
- What DfE/PH documents have you read/referred to support your RA?

Please do note that these questions have been advised to us by school colleagues who have had a call from HSE, other questions may also be asked during the call.

Please:

- Make sure you reflect current guidance,
- Keep your Risk Assessments under constant review, and up to date,
- And equally as important as 1 and 2, make sure you are doing what your risk assessment says – if you do not follow your own control measures, the HSE are not going to like it.





## Guidance for schools and FE providers on ordering additional coronavirus test kits

Schools should have now received this initial order; if you have not, please call the Test and Trace helpdesk at 119.

The fastest way to get a test result is to go to a testing site (Best of luck!). Individuals will need a pre-booked appointment or they will not be given a test. People can also order home test kits to be sent directly to them. To book an appointment or order a home kit, please visit:

These routes remain the primary channels for any individuals displaying coronavirus symptoms to get a test.

### Making an order for additional coronavirus tests

Schools and FE providers should order additional test kits if they have run out or are running out of test kits.

The portal will open for schools to apply for more test kits on the **16 September 2020**, via this link: <https://request-testing.test-for-coronavirus.service.gov.uk>.

Kits will be supplied in boxes of 10. The number of boxes available to each school or FE provider will be proportionate to your size.

You will be able to make a new order for coronavirus test kits 21 days after you receive a delivery confirmation email telling you that your kits have been sent.

Schools and FE providers will need a Unique Organisation Number (UON) to place orders for test kits. You will receive your UON by email to this email address on or before 16 September 2020. After this date, please call the Test and Trace helpdesk on 119 if you have not received your UON.

## **DfE Governance Advice – UPDATE – September 2020**

Please see below the latest advice received from the Department of Education regarding governance:

'The Department's advice remains as it was in the July Governance Update. Governing boards (chairs) should speak with the school leaders and work out a pragmatic solution which takes into consideration the school's risk assessment, and how the health and safety of any visitors, alongside staff and pupils, will be protected. We believe boards need to continue to take a pragmatic approach in regard to governing board meetings. We would expect the chair to keep the conversation open with the board members, to continue to test their views on how they wish to meet, and make arrangements as necessary, whilst observing social distancing. It could indeed be that some board members are happy to meet in person, and that some people want to dial in virtually. Therefore, arrangements for meetings must facilitate all such members' needs, so that boards can function effectively - clerks will be essential in facilitating this.'

17 full survey have been complete and published with others due for completion in the coming weeks. All main consultants are reporting an intensive programme of school surveys scheduled for this term.

Training for Diocesan Finance Officers took place yesterday. It involved Diocesan Finance Officers from across England.

The anticipated mid-year assurance return to the DfE/ESFA has been cancelled (Covid-19). We continue to work with Statlog, and with colleagues from other Diocese, to ensure that a consistent reporting mechanism is developed and approved by the Government.



## **Priority School Building Programme**

Project managers continue to monitor the progress of schools in this scheme.

The land/property issues delaying progression at Douay Martyrs have been resolved, thanks to the support of Carol Haigh and Clive Horscroft, and the project is now moving forwards.

The DfE/ESFA are continuing to evaluate the cost implication of reverting to new build options at St Joan of Arc and at John Henry Newman. We continue to engage with the Project Managers from the ESFA and with the respective CAT Boards in these matters.

### **1<sup>st</sup> Planner – Demographic Survey**

Further discussions with the Greater London Council are scheduled for tomorrow. The GLA is keen to learn more about the Win Win Initiative developed by the Diocese. The need for social housing in London is significant but most Landlords continue to avoid the provision of affordable social housing and key worker accommodation in their developments. This is presenting the Church with a genuine opportunity to invest in the poor and marginalised in our society. Keyworker accommodation, accessible recreational spaces and social enterprise initiatives are all at the Core of our Mission as a Church. Making the estate work for the benefit of the Church is an imperative if we are to thrive in the 21<sup>st</sup> Century. Mixed usage offers the potential for the Church to deliver outstanding education in modern and well equipped schools, whilst capitalising on the potential income that could be generated through the efficient use of air space and land adjacencies on existing Trust Assets.
