Relationships and Sex Education

The Education service has produced various documents to provide support with the planning and delivery of statutory RSE. These can be found on our website here <u>Education support documentation</u>. The frequently asked questions booklet is to help you to address questions from students, parents and staff. It addresses some of the issues explored in our training and is based on topics from the model curriculum.

The mapping documents cross references the DfE guidance and the CES model curricular so that you can be assured of coverage of the DfE guidance when delivering the CES model curriculum. In the cross referencing document those parts that are in red font indicate where there is a link with the content of the curriculum and the DfE guidance but you will need to make sure you explicitly address the point from the DfE. Again, in the health curriculum cross mapping there are links rather than coverage as the CES model curriculum is an RSE not Health curriculum.

Week 7: The miracle of kindness

From the sixth chapter, "*Dialogue and friendship in society*", further emerges the concept of life as the "art of encounter" with everyone, even with the world's peripheries and with original peoples, because "each of us can learn something from others. No one is useless and no one is expendable" (215). True dialogue, indeed, is what allows one to respect the point of view of others, their legitimate interests and, above all, the truth of human dignity. Relativism is not a solution – we read in the Encyclical – because without universal principals and moral norms that prohibit intrinsic evil, laws become merely arbitrary impositions (206). From this perspective, a particular role falls to the media which, without exploiting human weaknesses or drawing out the worst in us, must be directed toward generous encounter and to closeness with the least, promoting proximity and the sense of human family (205). Then, of particular note, is the Pope's reference to the miracle of "kindness", an attitude to be recovered because it is a star "shining in the midst of darkness" and "frees us from the cruelty ... the anxiety ... the frantic flurry of activity" that prevail in the contemporary era. A kind person, writes Francis, creates a healthy coexistence and opens paths in places where exasperation burns bridges (222-224).

Inspection Update

Ofsted plan to resume inspections in the summer term. Full parity between s5 and s48 inspections is an important principle to which both the DfE and the CES are committed. Therefore, it is likely that denominational inspection in some form will recommence after Easter. At this time, it is not clear whether the resumption of denominational inspection in the summer term will be a requirement to inspect or a permission to inspect. This will depend very much on whether the DfE accept the CES' proposed regulatory changes that will allow dioceses to catch up on their outstanding inspections and even out the schedule without risking non-compliance. It is clear that one of their initial proposals of simply using this year as the catch-up year is now no longer possible, since this would require completing all the incomplete inspections from 2019-2020 in one term.

Now that we have a proposed start sate, inspections can be scheduled for the summer term and the appropriate training can be arranged.

Per Pupil Funding Agreement Update

I would like to begin by thanking the majority of schools who have already responded to the *Per Pupil Funding Arrangement* (PPFA) request issued by JP Morrison in September. In his communication to schools, JP wrote detailing the rationale behind the PPFA and details of both the essential and supplementary services these contributions enable the diocese to provide which support all schools to discharge their duty as a Catholic school and deliver the outstanding provision for the formation of the children and families we all serve. This was followed in November by a further prompt from Fr Michael Dunne, Chair of the Diocesan Education Commission, in which Fr Michael acknowledged, quite rightly, that whilst there have been many priorities needed to be addressed to keep schools open as a result of the coronavirus, administrative tasks can, for good reason, be placed to one side.

The Diocese are very aware of the additional financial burdens coronavirus has placed upon school budgets, although that is also true of the Education Service finances. Every contribution counts and there are still some schools who have not yet responded to the PPFA request. Therefore, before the end of this term, I would be grateful if you could turn your attention to one last task for and ensure your school has responded to the PPFA request. It is vital and only fair that despite the current challenging circumstances, every school plays their part to support the Education Service as you have done so magnificently in recent years.

Foundation Governor Applications Update

During the last round of Regional Hub and Chair of Governor Meetings it was announced that following a review of the application and renewal process for Foundation Governors that we intended to introduce a more streamlined online application process that will alleviate the delays many of you may well have experienced previously.

Please look out for a separate communication which will be issued later this week, detailing the new process. A key change is that instead of the diocese seeking to collect the supporting documentation from referees, we are asking that the school does this instead. We believe that there is more likelihood that this will be effective when it is done locally than when done centrally. In addition, we have redesigned the process so that it can take place completely electronically. **This new system will operate for all applications after the 1**st **January 2021.**
