


COP26, Celtic and Free Resources.

Farmington Scholarship 2022/23

O Applications for the 2022/23 Farmington Scholarships are now open. These are Scholarships available to teachers of religious education and associated subjects in UK secondary, primary, and special needs schools. Head teachers who wish to undertake research into either religious education or values education are also eligible to apply. Scholarships cover the cost of tuition, essential local travel and, by negotiation with the school, the salary of a replacement teacher up to point 6 of the main pay scale. Scholarships last for a maximum of 30 days and can either be taken at a local university (we have links with 13 throughout England, Scotland, Wales and Northern Ireland) or can be home-based with a local tutor. Holocaust Memorial Day

Holocaust Memorial Day (HMD) is on 27 January, and there are lots of free resources online to help teachers lead assemblies, activities or lessons with students. New this year are lesson plans about the *Kindertransport* and a flexible set of worksheets called 'Days to remember', which give an introduction to different genocides through one day, one person and one artefact.

You can find all the school materials at www.hmd.org.uk/schools.

Marking HMD helps your students to learn about the Holocaust, Nazi persecution of other groups, more recent genocides and contemporary issues. They will increase their knowledge, empathy and desire to take part in social action. This is especially important at a time when hate crime, extremist views, antisemitism and anti-Muslim hate are on the rise.

CCRS - February 2022

Are you interested in developing your knowledge to support your teaching of RE? Are you interested in a Senior Role or Leadership in a Catholic School?



Halo Hair Code

We are excited to announce that St. Dominic's Catholic Primary School has adopted 'The Halo Code', the UK's first Black hair code. No Black staff or students should have to change their natural or protective hairstyle in order to thrive at our school. We hope that the Halo Code will move us one step closer to a world free from discrimination, where all Black members of our community have their identities fully recognised and celebrated.





Proud to Be

The theme for Black History Month was 'Proud to Be' our parents at St Dominic's Catholic School spoke with the deputy headteacher and shared what they are proud to be. For example, some parents stated they are proud of their ethnicity, speak a different language, and being a black hard working mum.



World Afro Hair Day (Big hair day) - Wednesday 15th September

World Afro Day is a global day of change, education and celebration of Afro hair; endorsed by the UN Office of the High Commissioner for Human rights. Learn about Community Sponsorship of Refugees

Thursday 9th December 2021, 2pm – 3:30pm online

Join us to find out how your school or community group can create a safe route from a refugee camp to your neighbourhood, and welcome a family through the **Community Sponsorship Programme**.

On the news we hear that thousands of people risk their children's lives in flimsy, overcrowded boats to cross the channel. How desperate must they be, to hand over all their savings to a stranger to get them here. What terror must they be escaping to make that choice? Instead of punishing those who make these treacherous journeys, we are asking the government to add more safe routes so that people fleeing war, persecution and climate change don't have to seek such desperate measures, but instead receive a warm welcome and the support they need to thrive alongside the local community. With the resumption of UNHCR flights from refugee camps, Community Sponsorship is a vital way to welcome refugees who are seeking a safe place to call home. 99 families have already been welcomed and well-integrated into communities by churches, schools and community groups across the UK (figures from 2016-2020).

This meeting is an exciting opportunity to learn more about the Community Sponsorship scheme and have any questions you might have answered by those leading on this area in London and nationally. Governance Update

School Admissions

 From recent communications with schools around their admissions policies, two main areas have been highlighted where we would like to emphasise our desire that all schools follow the CES model policies.

The first is around priority given to catechumens as evidenced by a certificate of reception in to the order of catechumens. Priority should not be given to children of catechumens. Children under the age of seven are not eligible for admission to the Catechumenate.



The second is around the home address of the child for whom a school place is being applied. The model policy says 'A child's "home address" refers to the address where the child usually lives with a parent or carer, and will be the address provided in the Common Application Form ("CAF"). Where parents have shared responsibility for a child, and the child lives for part of the week with each parent, the home address will be the address given in the CAF, provided that the child resides at that address for any part of the school week.' Many schools explain the home address as where the child resides for at least 50% of the week, but we would prefer the use of the wording in the model policy relevant to your school that is on the diocesan website.

- 2. Now that the consultation window has opened for Admission Policies for the year 2023/24, we would like to emphasise to all schools the importance of using and following the model admissions policies from the CES that are on the Diocesan website, remembering that if you make any changes to the oversubscription criteria, you should retain, as far as possible, the order as set out in the model policies. Model policies are available for primary & secondary and for schools using the CCP and not.
- 3. Queries relating to admissions and staffing policies should be sent to Deb Long at schooladmissions@rcdow.org.uk who can advise and seek further clarification where necessary.

Schools and governing boards should not contact the CES directly.

CES Policies

We would also like to recommend the importance of using the CES staffing policies available on their website – Sickness Absence, Disciplinary, Grievance, and Capability. Whilst these policies are available in an amendable format on the CES website, we would strongly advise that you only amend to include your school details and leave the rest as set out by the legal team at the CES. In doing this we are better able to support you in the event of finding yourselves needing support and guidance because of a staffing issue.

Process for appointing foundation governors / directors

We ask that your school appoints a Nominated Person (either the Clerk to Governors or perhaps, someone in the School Office) who will administer this process.

The Nominated Person should download the suite of forms [available here] and personalise them to the school, including the email address of the nominated person.

The Nominated Person will send the application to and receive the application from the applicant. The Nominated Person will seek the references and the DBS certification. (Note: the parish priest may wish to return the reference directly to the diocese; if they wish to do this, they have been asked to let the nominated person know).

When all references and Clearances are available, the Nominated Person will upload all documents to the Diocese using this secure link **here**. A receipt will be sent to the Nominated Person and the Applicant on submission.

The Diocese will determine the complete application within 21 days, either with a letter and deed of appointment, or other communication.

169 out of 205 sites currently subscribed to Statlog. 135 out of 205 sites currently setup for Site Manager Tests. 133 out of 205 sites currently setup for Specialist Contractor Tests.

One school has registered as a Statlog user since the last update.



155 surveys are complete or nearing completion. Consultants have a further 14 surveys to complete and then every licenced school will have an up-to-date Statlog Survey. Whilst the level of investment required in registered schools is significantly greater that previously forecast, the quality and equality of the data is helping to ensure that the highest priority needs are address first.

Project Manager Lite (PML)

On 31st December 2021, any of the £1.5M of Matched Funding assigned to School that remains unused will be clawed back. Funding to projects that are currently in development will be honoured as long as the project has reached the stage where the letter of appointment has been issued to the contractor.

CAUTION: Please check that SBMs and others complete all sections of the PML process. Some colleagues have started well and then deviated from the Statlog System. The Diocese cannot make payment on projects where the prerequisite evidence is missing. The main areas of weakness appear to be:

- Quotation Return and Adjudication, and
- Invoice upload

For full transparency and audit purposes, all elements of the Statlog Process must be recorded electronically. If a contractor fails to provide their quotation in the required format, their submission cannot be accepted. Please work with contractors and help them to understand our requirements.

Approved Initiatives

Condition Data Collection (CDC)

The Government has commenced the latest round of its Condition Data Collection process. Schools will be contacted by surveyors appointed by the Government. This process is monitored by the Education Service, but we do not normally attend any of the engagement sessions. The surveyors are expected to contact you in advance of any proposed site visit. Please contact nigelspears@rcdow.org.uk if you have any questions about this process. If we receive advanced notification of a block of visits, we will publish that list in the bulletin.

Insurance Validation

The Catholic Insurance Service and Zurich have commissioned an audit and appraisal of schools insured via the CIS. The Diocesan Trustees are paying for this initiative and targeted schools will be approached by a company called Charterfields. If your school is targeted during this initiative, please supply Charterfields with the data and access they required.
