

CARE FOR CREATION

The Catholic Church observes the Season of Creation throughout September, beginning with the World Day of Prayer for the Care of Creation on 1st September which was established by Pope Francis. This special day is meant to encourage Catholics around the world to come together in prayer and action for the care of our common home.



This observance is deeply connected to Pope Francis' encyclical Laudato Si', in which he calls on "every person living on this planet" to take responsibility for the environment. The 2024 theme, "Hope and Act with Creation," is inspired by the Letter of St. Paul to the Romans (Romans 8:19-25), which speaks of creation longing for renewal and hope in God's promise.

In his 2024 message, Pope Francis highlights the role of the Holy Spirit in guiding the faithful toward lifestyles that resist environmental degradation. He encourages us to seek transformation in our habits, striving to live lives that reflect love for God, humanity, and creation. By doing so, we can embody a song of praise that ultimately leads to holiness.

This season, therefore, is not only a time of reflection but a call to action, urging us to care for creation with hope and responsibility.

During this season, Catholic schools, parishes, and individuals are encouraged to incorporate prayers, teachings, and practical steps that support environmental sustainability, fostering a deeper connection with the world God has entrusted to us.

Prayer and Liturgy Directory Updates


The Prayer and Liturgy Directory needs to be implemented in all school by September 2025.

This year our support for RE will focus on the model curriculum including the 'knowledge lenses' and 'ways of knowing'.



 - o Are lenses interpreted accurately?



Catholic life AND MISSION

The annual Christian celebration is convened each year to pray and respond to the cry of Creation, between September 1st, the Feast of Creation, and October 4th, the Feast of St. Francis of Assisi.

This year, the symbol that will guide the season is "The first fruits of hope," inspired by Romans 8:19- 25. The times we live in demonstrate that we do not relate to the Earth as a gift from our Creator, but as a resource to be used. "Creation groans" (Rom 8:22) because of our selfishness and our unsustainable actions that harm it. However, Creation teaches us that hope is present in waiting, in the expectation of a better future (cf. Rom 8:20-21).

To hope in the biblical context does not mean to remain still and silent, but to groan, to cry out and to struggle actively for a new life amid difficulties. Creation and all human beings are called to worship the Creator, working for a dynamic future from which the firstfruits of hope can spring.

During the Season of Creation, we also mark the Harvest Festival which is a traditional time when we remember and celebrating how God has blessed us with a successful gathering of the year's crops. The Harvest Festival in 2024 falls on the 4th of October. We encourage our families to donate fruit and vegetables and other products to those in need. It is also a time for honouring those who grow and reap crops. For our pupils, most of whom, live in an urban setting, it is also a great time to explore how food is grown and harvested here in the UK and around the world. It is also an excellent opportunity to explore with your pupils' issues of food poverty, famine and Fair Trade.

DfE announcement, single-word judgements and the Catholic Schools Inspectorate

The Department for Education announced last week that they are intending to introduce a School Report Card inspection system from September 2025. The details of this, and the necessary legislation to bring it about, will be worked out over the coming months. In the interim year, for state-funded schools, they have instructed Ofsted to scrap the use of the single-word overall effectiveness judgement grade. We understand that due to the current constraints of legislation, the overall effectiveness single-word judgement grade will remain for all other kinds of setting which Ofsted inspects, including sixth form colleges, non-maintained special schools, and non-association independent schools. Single-word judgement grades will continue to be given for the subcategories until the current education inspection framework (EIF) is superseded in September 2025. In addition, schools that would have previously been graded as inadequate, will still be labelled either as 'special measures' or 'requiring significant improvement', with all the attendant consequences of such an outcome. Ofsted's response to their Big Listen was also published last week and can be accessed here.

All of this has implications for the Catholic Schools Inspectorate. We will be working closely with the DfE and Ofsted over the coming months to understand the details of the new accountability landscape for the secular inspectorate. Once its shape is clear, we will be able to prepare a response and make proposals for the future direction of the National Framework for Inspection. Before any changes can be implemented, these will need to undergo wide consultation and formal approval from the Department of Catholic Education and Formation of the Bishops' Conference. The September 2024 edition (v3.1) of the CSI handbook was published last week to reflect the changes in Keeping Children Safe in Education, and we do not intend to make any further changes to the Framework until this process of reflection, consultation and approval is concluded. The latest version of the Handbook, change log and supporting documentation can be found on the <u>CSI website</u>

We understand that there may well be an expectation from school leaders that the Catholic Schools Inspectorate would also immediately scrap the use of the single-word overall effectiveness grade. However, there are several reasons why this is more difficult for us than it is for Ofsted. First, as before, the DfE grant funding is connected to the overall effectiveness grade and we will be required to continue to report this grade to the DfE in this interim year. If we are reporting a school grade to the DfE, it would lack integrity to keep this from school leaders and our own bishops. Second, some Catholic schools (as outlined above) will continue to receive single-word overall judgements from Ofsted. Even for those that do not, it will still be possible to calculate the grade they would have received using the current overall effectiveness grade descriptors. Continuing with our current framework maintains a parity between all kinds of Catholic school and with those that have already been inspected under the National Framework. Third, our current overall effectiveness grade is tied into judgements on compliance with the requirements of both the Bishops' Conference and the diocesan bishop. Work would need to be done to understand how our current compliance checks would feature in any framework that lacked the overall effectiveness grade and it is likely that a redrafting of the Framework itself would be necessary. This cannot be done quickly or without due process. Finally, any substantive changes to the framework will require the approval of the Department of Catholic Education and Formation who would expect us to have made formal proposals, and to have consulted on these, before seeking their authority to introduce an updated National Framework for Inspection. This will take time, and it would be unwise and confusing to embark on such a process, when we are anticipating a larger review of the Framework within this academic year.

Please be reassured that inspections will continue to be carried out with love, integrity, and compassion. Please also be assured that a review is imminent, and that in the interim we request patience with the pace that integrity necessitates, as we consider reforms to the framework.

Racist Riots and Counter Protests

We imagine all of you watched in horror as the racist riots took place across the country over the summer and were relieved to see the counter protests.

Most of our pupils come from immigrant families and for many this may be the first time they saw images or witnessed scenes that made them feel fearful and unsafe in our country.

As a result, the Education Service produced a powerpoint that can be used to acknowledge and address these events in your school. There is a script on the note section beneath each slide and schools can adjust and adapt it as needed.



Across the school estate, we failed to reach the targets set by the Diocesan Trustees for overall compliance. This failure places staff and pupils at risk and insurance undermines potential School leaders, governors and directors may be held to account by the Health and Safety Executive, if an accident occurs on your site and the evidence of compliance is weak or missing. Statlog is the only tool authorised by the landowners for the management of statutory compliance. 

Whilst this day is particularly geared towards parishes, it would also be helpful to the accompaniment of staff who want to explore Christianity in a one to one context.
